Dimensions are 8 feet long, 3 feet deep, bottom level 3 feet from floor, 3'-11" from bottom level to ceiling of booth. Exhibitor provides own covering for deck and walls as desired. These displays are judged.

(No campers, motor homes or vehicles are allowed to be used as a booth)

\$7.00 SURCHARGE FOR ELECTRICITY (back row only)

INSIDE BOOTHS (w/ attendant)

Are on the floor, approximately 6' deep and 8' wide and separated on three sides by fabric curtains (floor to ceiling in the back, floor to three foot level on sides.)

NO pins on the curtains please.

Attendant must stay with the booth at all times. Vendor must supply their own tables. If more than a standard space is needed the fee is prorated. Please check with the secretary for availability. Some tables available for use inside only—please contact secretary in advance to arrange.

\$50.00 FEE PER BOOTH. (\$7.00 ELECTRICITY SURCHARGE)
